Katie

- GRC
 - Chris Kello memo to DivCo? asking that GRC get split into GC and RC
 - GC to include all grad group coordinators
 - RC to still just have a rep from each grad group

Kristynn

- Student Regent Selection Committee
 - Went to meeting
 - Some overlap with UCSA
 - Top five from southern and northern councils get sent to UCSA
 - Then UCSA gives top three directly to the Regents
 - \circ Need to get a person to vote in Kristynn's place because of the overlap
 - \circ May 7 for the UCSA meeting
 - Beth volunteered to attempt to make it in Kristynn's stead
- UCSA
 - ° Talk about "taxing" on student fees (UCOP) funneled back to the campuses
 - Raise student fees without raising student fees?
 - Ambiguous where the money is actually going.
 - UCSA not liking the language of the bill
 - Also might suggest that grads be exempt

Katie - GRC trying to remove NRTs

• Seems to be a cycle of money that doesn't do anything

Beth

- Tutoring with first graders
 - Going well
- Tried contacting fifth grade
 - But didn't go past second grade
- Summer session money
 - From indirect cost returns (\$500,000)
 - Maybe start being used as graduate funding in the humanities?
 - Some might go to schools for discretionary funds already
 - Maybe need to put it in for student funding instead?
 - Indirect cost returns split 150 to NRTs, 100 to recruitment, and 250 to retention (summer fellowships)
 - Put into CRF and ORUs as other sources of funding
 - Some good, some bad sides
