GSA Budget review and voting

- Quy Lam, GSA Treasurer, presented on all parts of the GSA Budget Proposal
 - o The proposed budget for the 2020-2021 GSA is \$18,850
- Questions + Answers:
 - o Why do the EVP and LAO need a travel budget during this pandemic?
 - A: As part of their duties, these officers must attend different meetings, therefore to ensure they can fulfill their duties, our budget reflects all potential travel expenses. Unused money will rollover into the next year.
 - o What is the GSA Meeting & Events money being used for?
 - A: The GSA hosts events such as Trivia Night that include prizes of monetary value.
 - o Could you talk more about the UCGPC expense?
 - A: UCGPC is a UC-system wide organization that brings together leaders across the UC campuses to discuss and act upon student issues. The membership expense is proportional to the size of our graduate student body.

Reviewed and voted on Amendments 6 – 10

- Amendment 6: Revision of the responsibilities of the Climate Diversity & Equity Officer.
 - o Unanimous approval: 8 yeas, 0 nays, 0 abstain
- Amendment 7: Appointing temporary replacements for vacant seats in the Delegate Assembly

- Expressed concern about a resigning delegate being unable or unwilling to contribute to choosing their replacement and potential abuse of this rule.
- Unanimous <u>disapproval</u>, Amendment 7 does <u>not pass</u>: 0 yeas, 8 nays, 0
 abstain
- Amendment 8: Establishes Election Officer responsibilities
 - o Unanimous approval: 8 yeas, 0 nays, 0 abstain
- Amendment 9: Pools the legislative review process for the Delegate Assembly into one section
 - Unanimous approval: 8 yeas, 0 nays, 0 abstain
- Amendment 10: Have training for incoming Delegate Assembly cohorts
 - Unanimous approval: 8 yeas, 0 nays, 0 abstain

 - o What does 'Literature' mean in item 4a?
 - A: The GSA has been in conversation with the library to acquire more literature from BIPOC scholars.
 - Comment: Delegates are interested in being involved in conversations around retention of Black Graduate Students.
 - A: There are ongoing conversations with Dean Chris Kello, and the DA and
 - GSA can work to get more opportunity to speak with him, to express ideas and strategies around this issue
